Service Hours Required:

Each family is required to give a total of 35 service hours for Parish and/or School (single parents—25 hours). 10 of the total service hours must be done at the Parish Festival. Hours are to be worked between **June 3, 2011 and May 31, 2012**. Unfulfilled service hours will be billed at \$20 per hour. Unserved Festival hours will be billed at the end of the first semester. I have read the tuition contract and service hour policy requirements and agree to pay the stipulated tuition and fees. **I also agree to perform the required service hours. I also understand that a major part of my obligation to St. Catherine Parish and School for the 2011-2012 school year is regular attendance at weekend Mass.**

To receive the Active Parishioner Rate a family must use a minimum of 24 weekly offertory envelopes. The use of 23 envelopes or less will change tuition rate to Non-Parishioner. Our prayerful hope is that you and your family will become actively involved in the sacramental life of St. Catherine Parish which is part of the basic mission of St. Catherine of Siena School.

As of January 31, 2011, our records show that you have used _____ church envelopes between January 1, 2010 and December 31, 2010. Your tuition for the 2011 – 2012 will be based on envelope usage.
